In continuation to this office letter of even number dated 11.01.2019 and 11.06.2019 in compliance of the Hon<sup>u</sup>ble Supreme Court orders in Writ Petition No. 292 of 2006, UGC has decided the following actions to be taken by the Institutions immediately.

- Adoption and implementation of Harmonised Guidelines and Space Standards for Barrier free Built Environment for Persons with Disability and Elderly Persons, developed in February, 2016 by Ministry of Urban Development, Government of India, to make the existing buildings barrier free and accessible for Persons with Disabilities and the aforesaid guidelines shall also be followed during approval of the plan and Detailed Project Report in cases of new buildings.
- To form an Internal Committee comprising teachers, staff, students and parents for taking care of day to day needs of differently abled persons as well as for implementation of the schemes existing and to be devised in future.
- To report the proper functioning of Equal Opportunity Cell in the Colleges, Universities and other higher education institutions.

You are 'therefore, requested to implement the above mentioned recommendation in your University/ constituent and affiliated Colleges and furnish the action taken report to UGC at [sctsectio@gmail.com](mailto:sctsectio@gmail.com) within 10 days. The above matter will be listed in the next month, so that the status report may be placed before the Hon'ble Supreme Court in time.
