Please peruse a letter of the Assistant Registrar, Supreme Court of India, communicating the order of the Hon'ble Supreme Court dated 24.03.2025, passed in Criminal Appeal No. 1425/2025 (Amit Kumar & Ors. -Versus- Union of India & Ors.) received on 01.04.2025.

The issue involved in the present matter is student suicides in Higher Educational Institutions wherein the Hon'ble Supreme Court has directed to constitute a National Task Force to address the mental health concerns of students and prevent the commission of suicides in higher educational Institutions.

The Hon'ble Supreme Court, vide order dated 24.03.2025, interalia observed and directed as follows.

'59. The recurring instances of student suicides in Higher Educational Institutions, including private Institutions, serve as a grim reminder of the inadequacy and Ineffectiveness of the existing legal and institutional framework in addressing mental health concerns of students on campuses and to prevent the students from taking the extreme step of committing suicides. These tragedies underscore the urgent need for a more robust, comprehensive, and responsive mechanism to address the various factors which compel certain students to resort to taking their own lives. In light of the concerns expressed above, a National Task Force to address the mental health concerns of students and prevent the commission of suicides in Higher Educational Institutions is being constituted and shall comprise of the following members:

1. Justice S. Ravindra Bhat, Former Judge, Supreme Court of India, as the Chairperson;

iii. Prof. Mary E. John (retired), Former Director, Centre for Women's Development Studies, New Delhl;

71. We direct the Chief Secretaries of all the States/Union Territories to nominate a high ranking officer, not below the rank of Joint Secretary in the Department of Higher Education of the respective State/Union Territory, to act as the nodal officer on behalf of the respective State/Union Territory. We further direct all the concerned departments/authorities of the respective State/Union Territory to cooperate with the nodal officer concerned and furnish necessary information, data and assistance as may be sought by such nodal officer.

79. We also direct that the Central Government, the Governments of all the States/Union Territories and agencies thereof, and Universities shall extend their full and active cooperation to the Task Force and provide the requisite data, information and assistance, as may be necessary. In the case of delay, reluctance or neglect on part of the aforesald bodies, the Task Force will be at liberty to approach this Court through the amicus curiae seeking remedial actions.

Considering the directions of the Hon'ble Supreme Court, issued vide order dated 24.03.2025, the Higher Education Department may be requested to submit a file to the Chief Secretary, to nominate a high ranking officer, not below the rank of Joint Secretary in the Department of Higher Education.

Further, the Higher Education Department may also be directed to communicate the order of the Hon'ble Supreme Court to the concerned Departments and the Universities directing to cooperate with the concerned nodal officer and furnish necessary information, data and assistance as may be sought by such nodal officer and also to extend their full and active cooperation to the Task Force and provide the requisite data, information and assistance, as may be necessary.



Now, Hon'ble SCI, vide order dated 28.07.2025 (Copy enclosed) has inter-alia directed that all the Higher Education Institutions (HEIs) shall appoint a senior person (either faculty or on the administrative side) as a Nodal officer who will ensure that the NTF is able to conduct its field visit without any hurdle.
- 4. It has also been directed that all universities will keep the data about the students admitted under various reservation quotas readily available during the visit of the NTF and they shall permit these students to interact with the NTF without any hesitation.
- This issues with the approval of competent authority for compliance.

मा. सर्वोच्च न्यायालयाने उच्च शैक्षणिक संस्थांमधील विद्यार्थ्यांच्या आत्महत्यांच्या अनुषंगाने विद्यार्थ्यांच्या मानसिक आरोग्याबाबतच्या तक्रारींचे निवारण करण्यासाठी आणि विद्यार्थ्यांच्या आत्महत्या रोखण्यासाठी एक राष्ट्रीय टास्क फोर्स तयार करण्याचे निर्देश दिले आहेत. सदर प्रकरणी संदर्भाधिन क्र.०१ अन्वये महाराष्ट्र राज्याच्या वतीने नोडल अधिकारी म्हणून श्री. शैलेंद्र देवळाणकर, प्र. संचालक, उच्च शिक्षण संचालनालय, पुणे यांचे नामनिर्देशन करण्यात आलेले आहे.

संदर्भाधिन क्र.०३ मध्ये नमुद केल्याप्रमाणे, मा. सर्वोच्च न्यायालयाने दि.२८.०७.२०२५ च्या आदेशानुसार सर्व शैक्षणिक संस्थानी राष्ट्रीय टास्क फोर्सला क्षेत्र भेटीमध्ये आवश्यक सहकार्य करण्यासाठी एका वरिष्ठ अधिका-याची नोडल अधिकारी म्हणून नियुक्ती करावी, तसेच सर्व विद्यापीठांनी राष्ट्रीय टास्क फोर्सच्या भेटी दरम्यान विविध आरक्षण कोटयांतर्गत प्रवेश घेतलेल्या विद्यार्थ्यांची माहिती उपलब्ध ठेवावी आणि त्यांनी या विद्यार्थ्यांना कोणत्याही संकोचाशिवाय राष्ट्रीय टास्क फोर्सशी संवाद साधण्याची परवानगी द्यावी, असे निर्देश दिलेले आहेत. तरी या अनुषंगाने तातडीने कार्यवाही करण्यात यावी. ही विनंती.
