Dear Sir,

As you are aware, the University Grants Commission (UGC) is providing General Development Assistance to the Government and Govt. aided Colleges included under Section 2(f) and 12(B) of the UGC Act, affiliated to various Universities. There may be some Colleges affiliated to your University which have recently been included under Section 2(f) and 12(B) of UGC Act and did not receive General Development Assistance during the 11th Plan period. Now it has been decided to provide grant to all such Colleges as per UGC XII Plan guidelines "Guidelines for Development Grant to Colleges during the Twelfth Plan (2012-2017)". However, the ceiling of assistance to such Colleges will be based on the fulfillment of eligibility criteria indicated in the 11th Plan General Development Assistance guidelines of UGC. These XI Plan guidelines can be accessed on UGC Website www.ugc.ac.in.

You are, therefore, requested to kindly advise all such Colleges to send the proposals in the prescribed format as per UGC guidelines for the scheme, through your office, latest by 30th June, 2014.

It may kindly be noted that the self financed Colleges, though they are under Section 2(f) and 12(B) of UGC Act, are not eligible for financial support under the scheme.
